GENERAL TERMS & CONDITIONS:

- 1. The terms and conditions of deputation will be regulated in accordance with DoPT's OM No 6/8/2009-Estt (Pay-II) dated 17/06/2010 and No 2/11/2017-Estt (Pay-II) dated 24/11/2017 as amended from time to time.
- 2. The duration of deputation/lien/short term contract shall initially for a period of 2 (two) years and may be extended for a further period subject to the satisfactory performance of the candidate. However, the appointment may also be terminated at any time during the period of deputation, if performance of the candidates is not satisfactory or without citing any reasons.
- 3. Appointment against the post advertised shall be **purely on deputation/lien/short term contract basis**, the NIT Arunachal Pradesh would have no liability whatsoever for sustaining the candidate recruited on deputation basis against any other permanent vacant post or permanent post to be vacant in future.
- 4. Only shortlisted candidates by the Committee constituted for the purpose shall be called for the Interview. The decision of the Competent Authority shall be final in this regard.
