NOTICE INVITING EXPRESSION OF INTEREST FOR PROVIDING, FIXING AND INSTALLATION OF 2 (TWO) NOS. BORE WELL ON TURN KEY BASIS AT NIT ARUNACHAL PRADESH CAMPUS AT JOTE.

National Institute of Technology, Arunachal Pradesh an Institute of National Importance is functioning from its permanent Campus at Jote, located at a distance of 25 KM from Itanagar. The permanent campus of the Institute is completely a residential type with around 1100 students and 300 Faculty, Staff members with their families are residing within the Campus.

To meet the demand of water in Academic departments, Research Establishments, Hostels, Residential Quarters, Canteens, Market Complex etc. in the Campus, it is proposed to install 2 (two) numbers of High Capacity Bore wells with required pipelines for carrying as well as lifting of water to Overhead tanks. The estimated requirement of Water in the Campus per day is 2,00,000 LT per day.

Accordingly, Expression of Interest (EoI) is invited from the Executive Agencies of Central Government/ Central Government Undertakings (PSUs)/ State Government for Providing, Fixing and Installation of 2 (Two) nos. of Bore Well with installation of required pipelines in NIT Arunachal Pradesh **ON TURN KEY BASIS** under following terms and conditions:

- (1) Executive Agencies along with the EoI need to submit tentative preliminary estimate for the work with copies of drawing and other documents pertaining to the Work.
- (2) It is advised to inspect and examine the site and its surroundings and satisfy themselves before submitting the EoI as to the nature of the ground and sub-soil (so far as is practicable), the form and nature of the site, the means of access to the site, the accommodation they may require and in general shall themselves obtain all necessary information as to risks, contingencies and other circumstances which may influence or affect their work.
- (3) The time period for completion of the Work shall be 3 (Three) months from the date of Award of Work.
- (4) The Short listed Departments/Agencies shall be invited for providing presentation on proposed project.
