In this connection, some moderation and correction can be made to the certificate and mark sheet copy as per the recommendation from all HoDs, Deans and Registrar I/C (ANNEX-13.23).

Senate may like to approve and put their views over it.

<u>Decision:</u> it is decided that format given in Annex-13.23 need to be adopted and in this regard necessary action to be taken.

#### Agenda Item 13.21: Correction of credit points in the academic curriculum

During preparation of UG & PG regulations, it has come to the notice of the Experts that there are some error in the credit points in the UG as well as PG mark sheet. Sample attached in **ANNEX-13.24**.

Senate may like to do the necessary correction as deem fit for.

<u>Decision</u>: Based on the course structure, credit points to be updated by DPPC and DUPC on or before 15<sup>th</sup> December, 2017.

### Agenda Item 13.22: Misc. if any with permission of Chair.

### A. Mandatory attendance for students for appearing end semester examination

### As per rules & regulations:

- a) Attendance in all classes (lectures, tutorials, laboratories, workshops, etc.) is compulsory. A student may be debarred from appearing on examination, based on the unsatisfactory attendance which is less than 80% of number of class held.
- b) Absence from classes without prior permission will be considered as an act of indiscipline. Such cases will be dealt with in accordance with clause 3.d. ("The Institute reserves the right to cancel the admission of any student, and ask him/her to discontinue his/her studies at any stage of his/her career on grounds of unsatisfactory academic performance, irregular attendance in classes or indiscipline.")
  Detailed rules regarding attendance in classes etc., are given below:

### RULES REGARDING ATTENDANCE

Following are the rules relating to attendance at classes:

- a) Attendance in all classes (lectures, tutorials, laboratories, workshops, EAA including its related camps and other publicised activities etc.) is compulsory. A student may be debarred from appearing at an examination on the ground of unsatisfactory attendance.
- b) The teacher concerned may condone absence from classes for a very short period due to unavoidable reasons provided he/she is satisfied with the explanation.
- c) If the period of absence is for a short duration (of not more than two weeks) application for leave shall have to be submitted to the Head of the Department concerned stating fully the reasons for the leave requested for along with supporting document(s). The Head of the Department will grant such leave.
- d) Absence for a period not exceeding two weeks in a semester due to sickness or any other unavoidable reason for which prior application could not be made may be condoned by the Head of the Department provided he is satisfied with the explanation.
- e) If the period of absence is likely to exceed two weeks, a prior application for grant of leave will have to be submitted through the Head of the Department to the Dean, Academic Affairs, with the supporting documents. The decision to grant or condone such leave shall be taken by the Dean (Academic Affairs) after considering the recommendation of the Head of the Department.

- f) It will be the responsibility of the student to get his absence from classes condoned by the appropriate authority.
- g) A student must intimate his/her absence to the Warden of the Hall in which he/she is residing, before availing of any leave.

In a meeting it is decided that, those students who have less than 80% attendance as per rule will be debarred from appearing end semester examination on the ground of unsatisfactory attendance. (Minutes of the meeting placed at (ANNEX).

Senate may like to give a proper direction/ decision to resolve this issue.

Decision: It is decided by the senate that,

- a) Students having less than 50% attendance will not be allowed to appear in the end semester examination.
- b) Students having attendance between 50-69% in any subject will have to pay Rs.4000/- as penalty.
- c) Students having attendance between 70-79% in any subject will have to pay Rs. 2000/as penalty.
- d) In no cases, medical certificate will be entertained.

## B. Commencement of M.Tech in Civil Engineering (Structural Engineering and Water Resource Engineering):

As per approval of DPR (Detailed Project Report) M. Tech in Structural Engineering and Water Resource Engineering is needed to be commenced from July' 2018.

Hence Senate may like to approve the same.

### Decision: After faculty recruitment, HoD, CE is asked to put it in the next senate.

C. Formation of Board of Studies (BOS) for various department.

Board of Studies BOS for every department needed to be formed for Revision of Syllabus.

Hence Senate may like to approve the same.

Decision: It is decided that, in this regard DUPC will take necessary action.

D. Change of course name from 'M.S.' to 'M.Sc.'

It is proposed that the course name should be changed from 'M.S.' to 'M.Sc.

<u>Decision</u>: It is decided that, in this regard M.S. coordinator should submit a proposal with proper explanations.
