As per instruction from ministry, for session 2019-20 seats for EWS may be less than 10% hence for equal distribution of seats, 40 seats has been considered for 2019-20 session and seat matrix is prepared above should be followed.

Agenda Item: 17.14. Seeking permission for merging 4th semester and 5th semester subjects of online MBA course and waiving of tuition fees for 4th semester.

Letter is received from HoD (H&M) for weaving off tuition fees of 3rd semester for online M.Phil because the completion of the course gets extended due to shortage of manpower and shortage of materials. Senate may like to give appropriate suggestions and approve the same

Agenda Item: 17.16: Seeking approval for the offline degree instead of online MBA for online students Shri Lalit Upamam and Shri Ravi Kaushik.
