





**1) Implementation and support of Enterprise Resource Planning (ERP) system in NITs and IEST, Shibpur.**

A communication received from Shri Anil Kumar Singh, Under Secretary, Ministry of HRD vide F.33-8/2018-TS.III dated 15<sup>th</sup> March, 2019 regarding "Implementation and support of Enterprise Resource Planning (ERP) system in NITs and IEST, Shibpur".

- i) Total cost for 3 years (excluding the cost of hardware) is Rs.2.95 Crore per NIT (Rs. 50 lakhs is basic cost (license fee) of software. Remaining Rs.2.95 Crore-Rs.50 lakhs is for customization, development and deployment cost for 3 years)
- ii) For a group of 20 NITs for 5-year projected cost is Rs. 21.90 crore (software + Hardware + Staff deployment etc.) Additional cost for adding an Institute beyond group of 20 NITs is Rs. 10 lakhs for basic software and Rs. 15 lakh per year for post deployment support.
- (iv) Hardware cost is variable depending on type of infrastructure NIT chooses.
- (iv) Up to 3<sup>rd</sup> year IIT Kharagpur will provide all support for Software + Deployment of software but Hardware and Staff required at individual NIT is not included.
- V) In this context, it is informed that Technical Education Quality Improvement Programme (TEQIP) encourages participating Institutes to enhance / strengthen management capacity, and the implementation of ERP is one of the activity for it. Project Institutes which do not have ERP system can develop and implement through TEQIP resources under component title Management Capacity Development (Institutes already having an ERP may further improve it).

- VI) As informed by the National Project Implementation Unit (NPIU), Centrally Funded Institutions under TEQIP-III may develop and implement ERP using TEQIP finance. Amongst the list of CFTIs, 9 NITs (Agartala, Arunachal Pradesh, Manipur, Meghalaya, Mizoram, Nagaland, Sikkim, Srinagar and Uttarakhand) fall under the Focus States and other 17 NITs (Allahabad, Bhopal, Calicut, Durgapur, Jaipur, Jalandhar, Jamshedpur, Kurukshetra, Nagpur, Patna, Raipur, Rourkela, Silchar, Surat, Surathkal, Tiruchirappalli and Warangal) and IEST, Shibpur are Mentor States. NITs located at Hamirpur, Delhi, Goa, Puducherry and Andhra Pradesh are not part of TEQIP-III phase and the ERP in these Institute is to be implemented from their own resources. No additional fund will be provided by Ministry of HRD to the Institute for this purpose.
- VII) As provisioned, the ERP will be funded from TEQIP-III in above mentioned 26 NITs and IEST, Shibpur and they may replicate IIT, Kharagpur's ERP at their Institutes. In another pilot initiative to replicate (and customize) IIT, Kharagpur's ERP for 20 project Institutes, NPIU is engaging the same professional team at IIT, Kharagpur which is managing its ERP.
- VIII) All the Institutes are, therefore, requested to kindly initiate further necessary steps as per recommendations contained in para 2 and provisions indicated in para 3 & 4 above for implementation of Enterprise Resource Planning (ERP) in their respective Institutes at the earliest possible)




