#### **NOTIFICATION**

This is notified for information of all concerned that District Administration, Papum Pare District, Govt. of Arunachal Pradesh vide Notification No. DC/PP/CVD-19/01/2020 Dated 11<sup>th</sup> January, 2022 has declared **NIT Complex, Jote** as **Micro Containment Zone** for a period of 14 days w.e.f. 11/01/2022 to 25/01/2022 as clustering of COVID -19 positive cases have been detected from the inmates of NIT Arunachal Pradesh.

In view of above all Faculty members, Staff, Students and others residing in NIT Arunachal Pradesh Campus are hereby requested to follow **SOP strictly** as per the Notification No. DC/PP/CVD 19/01/2020 Dated 11<sup>th</sup> January, 2022, which is attached herewith.

Further, in continuation of the Office Order NIT/AP/Estt.113/COVID-19/2019-2020/2007 dated 07/01/2022, this is also notified that the regular plying of Institute buses as well as other vehicles to and fro from the Institute Campus has been suspended till 25/01/2022 or withdrawal of Micro Containment Zone whichever is earlier.

As a precautionary measures Faculty members, Staff and persons engaged from third party (Outsourcing Agency) including Security personnel deployed from the Security Agency are requested to **be fully vaccinated (2 doses)** and also requested to submit a copy of vaccination certificate to the concerned HoD/Sectional Head/ Officer-in-Charge as early as possible.

All HoDs and Sectional Heads including Officer-in-Charges of Security and Third Party Staff are requested to submit consolidated report regarding fully vaccination status of Faculty members, Staff and persons engaged by third party and Security Agency under the control of the respective HoD/Sectional Head/Officer-in-Charge to the Registrar's Cell for record **on or before 26/01/2022**.

## **CONTAINMENT NOTIFICATION**

Whereas, a recommendation has been received from the District Medical Officer, Papum Pare district, Yupia vide letter No. DSU/MPP/ 2021/01 Dated 11th January, 2022, regarding proposal for declaration of "NIT Complex, Jote" under Sangdupota Circle as Micro Containment Zone as clustering of COVID-19 positive cases have been detected from the inmates of the NIT, Jote on random RAT test conducted in the campus by the medical team of District Rapid Response Team and staff of PHC, Basernallo.

Therefore, in pursuance of order issued by the Ministry of Home Affairs, Govt. of India under Memo NO. 40-3/2020-DM-1(A) Dated 29<sup>th</sup> April, 2021, "NIT Complex, Jote" under Sangdupota Circle is hereby contained and the inmates of the above Institute is under home quarantine for a period of 14 (Fourteen) days w.e.f. 11.01.2022 to 25.01.2022.

The following SOPs shall be strictly complied with:-

1. The DMO, Papum Pare shall immediately collect samples of the primary and secondary contacts for COVID-19 test.

2. No unauthorized persons shall be allowed to enter or exit from the above area without prior approval from the ADC Balijan/MO i/c Basernallo/OC PS Balijan.

3. The movement of people for supply of essential items and other emergency services shall be regulated and police/ security guard shall be deployed by the SP, Yupia to regulate the movement.

4. The DMO, Yupia shall deploy staff to oversee the immediate medical need of the inmates in the above area as may be required.

5. The essential items required by the inmates shall be provided by coordinating with shopkeepers/ Home delivery firms by the CO, Sangdupota in coordination with the police and health workers.

6. The DMO/DSO, Yupia shall carryout antigen/RT-PCR/Truenat testing of all the inmates of the area as per SoP and instruct the period of quarantine etc and other follow up action to be taken.

7. The Sanitization of the area shall be carried out by the DDMO, Papum Pare District.

8. No gathering will be allowed in the above area.

9. CO, Sangdupota will make public announcement in the area regarding declaration of micro containment zone.

The violators shall be prosecuted under section 51 (b) of Disaster Management Act, 2005 and under section 188 of IPC.

The Superintendent of Police, Yupia, DMO Yupia and CO, Sangdupota are enjoined upon to enforce this order.
