NOTIFICATION

Sub: Preventive measures to contain the spread of COVID-19- reg.

In view of the unprecedented surge of the COVID-19 cases, it is necessary to take following measures/steps to prevent its spread in terms of the Circular No. ED/HE-06/2008 dated 26th April, 2021 by the Department of Education, Directorate of Higher & Technical Education, Govt. of Arunachal Pradesh:

- 1. All offline classes for all courses shall be suspended w.e.f. 1st May 2021 to till further order.
- 2. All academic activities including classes and examination will be conducted **ONLINE/BLENDED Mode** as per the academic calendar.
- 3. All hostels will be closed down from 1st of May 2021. All the boarders/students shall vacate their respective hostels before 1st May, 2021.
- 4. Students shall be mentored by the faculty members through online mode till completion of syllabus and clearing of doubts.
- 5. All the offices of the Institute shall remain open following all the COVID-19 protocols and SOPs.
- 6. The faculty members, officers and non-teaching employees shall not leave the station without prior permission/approval of the Competent Authority. Anyone found doing so will be treated as absent from duty.
- 7. Use of face mask is compulsory in the offices/work place in the Institute Campus.
- 8. Engineering Cell will arrange sanitization facility at appropriate point.
- 9. All kind of mass gathering/ function, etc is strictly prohibited. Manager of the Institute canteen must ensure social distancing while serving food avoiding any gathering in the Canteen. Necessary precautions must be taken while preparing food and serve it to the customer.
- 10. Unnecessary movement of the employee in the Institute Campus is restricted.
- 11. Entry of the outside visitors is strictly restricted to the Institute premises.
- 12. Anybody with sign & symptoms (cough, fever or difficulty in breathing) should call National Toll-Free Helpline 1075 or State Helpline numbers for any queries and they are advised to go for COVID-19 Test in nearby testing centre.
- 13. The guidelines/protocols including latest SOPs issued from the Government or any other appropriate body from time to time keeping in view of changing situation shall be notified in due course.
