NATIONAL APPRENTICESHIP PROMOTION SCHEME

In an endeavour to promote apprenticeship in India, i.e. National Apprenticeship Promotion Scheme (NAPS) has been launched by the Government of India in August 2016. The scheme entails financial support to establishments undertaking apprenticeship programs.

- 1 Easy accessibility to Online Portal Registration for Establishments, BTPs and Candidates
- 2 An establishments can engage apprentices of age 18 & above in normal working hours
- 3 Apprentices can be hired for all functions within the manufacturing, services, trade and other sectors
- 4 An establishment to engage 2.5% - 15% of their total workforce as apprentices
- 5 Courses under NAPS (164 Designated & 400 above Optional trade)

Eligible Entities / Establishments / Units

- ✓ Proprietorship / Individual
- ✓ Company
- ✓ Partnership firm
- ✓ BOPs
- ✓ SOEs
- ✓ Hindu Undivided Family (HUF)
- ✓ Local Authorities
- ✓ Government
- ✓ Unincorporated Associations or a body of individuals
- ✓ Others

BENEFITS FOR ESTABLISHMENTS

- 1 **Basic Training Cost**
Up to an amount of Rs. 7,500 for training to Basic Training Provider (BTP)
- 2 **Reimbursement of Stipend**
Up to 25% or Rs. 1,500 whichever is lesser to be reimbursed to establishments from Govt. of India
- 3 **Exemption**
Establishments may be relieved from contribution of PF and ESIC for apprentices but group insurance coverage may be done in case of hazardous work
- 4 **Course Customization**
Establishments can develop their own Course Curriculum and upload in NAPS Portal for approval



Eligibility criteria for Apprentice : ITI Passed /Trained under PMKVY, MIES-SDU/Graduate/ Diploma in Engineering/S class pass is minimum required

Benefits to Apprentice

- ✓ Monthly stipend of Rs. 5,000 or 20% during apprenticeship period (Based on education qualification mentioned in curriculum)
- ✓ Practical knowledge/OJT and application of skills
- ✓ Career growth opportunity
