- 1. The vendor should Design one point solution to IP based CCTV surveillance system requirements. Part solutions received from the bidders will not be entertained. The solution proposed by the bidders should meet the following basic conditions:
 - (a) All system / components should be compatible with each other along with software if any.
 - (b) All system / components must of world class brand.
 - (c) All system / components should have auto synchronization provision with system.
 - (d) Hardware should be compatible with third party software.
 - (e) System should be compatible with Mobile device (Android/ iPhone) & operating system.
 - (f) System should be capable to handle heavy data.
 - (g) System response time should be less than a second.
 - (h) Provision for internal and external backup.
 - (i) System should have LAN/RJ45, Wi-Fi (optional) provision & able to work on Local Area Network.
 - (i) All software's should be genuine and of the latest version. (Software and hardware patches/update should not be chargeable).
