OFFICE ORDER

The undersigned is pleased to declare the National Institute of Technology Arunachal Pradesh, Jote, as a tobacco-free campus. In this connection, all teaching and non-teaching staff, students, and family members residing on the campus are directed to follow the instructions given below:

- 1. Entry of persons carrying or keeping tobacco in any form, such as cigarettes, pan masala, bidi, gutka, tobacco pouches, etc., is strictly prohibited inside the institute campus.
- 2. Consumption of tobacco in any form, including smoking, chewing, vaping, or other means, is strictly prohibited inside the campus.
- 3. Throwing or disposing of cigarette/bidi butts, or discarded gutka/pan masala/tobacco pouches, and spitting spots is strictly prohibited inside the premises.
- 4. Shopkeepers, vendors, and other sellers are strictly prohibited from selling tobacco products within a radius of 100 yards from the institute boundary. Violation shall be penalized lawfully as per section 6b of COTPA-2023 and section 77 of the Juvenile Justice (Care and Protection of Children) Act, 2015.
- 5. make a sentance "In case, any individual found violating the rules within the territorial jurisdiction of the institute shall face face disciplinary action and a fine of Rs. 1000/- shall be imposed as a penalty.

In case any individual is found violating the rules within the territorial jurisdiction of the institute, they shall face disciplinary action and a fine of Rs. 1000/- will be imposed as a penalty.
